Only such relationships with the freedom fighters are not adequate but the candidate should remain actually dependent of the freedom fighter. It is advised that now the candidates may obtain the reservation, certificate from the District Magistrate in terms of Govt. Order No. 453/79-V-1-15-1(Ka)/14-2015 dated 07-04-2015 in the prescribed format and submit the same.
- 16. Be sure to mention the name of Post applied for, advertisement number, department number, date of birth, O.T.R. No. and Application ID for correspondence with the Commission.
